Sir/Madam,

Please refer to your letter No. 689/19, dated 18.03.2019 (received in this Council on 02.04.2019) forwarding therewith demand draft No. 767320, dated 16.03.2019 for Rs. 13,500 as balance amount of assessment fee with regard to Recognition of MD(Pathology) qualification for 2 seats.

In this connection, your kind attention is invited to the Post Graduate Medical Education Regulations, 2000, Clause 6(2) "STARTING OF POSTGRADUATE MEDICAL COURSES AND THEIR RECOGNITION", which reads as under:-

"(2) The institution shall apply for recognition of the Postgraduate medical qualification to the Central Government through the affiliating university".

In addition to above, kind attention is further invited to Section 11(2) of the IMC Act, 1956, which reads as under:-

"11 (2) Any university or medical Institution in India which grants a medical qualification not included in the First Schedule may apply to the Central Govt., to have such qualification recognized, and the Central Government, after consulting the Council, may, by notification in the official Gazette, amend the First Schedule so as to include such qualification therein, and any such notification may also direct that an entry shall be made in the last column of the First Schedule against such medical qualification declaring that it shall be a recognized medical qualification only when granted after a specified date."

In view of position explained above, it has been noted that you are request is still incomplete for want of the following:-

- Formal request through the affiliating university to the Central Govt., Ministry of Health & Family Welfare, New Delhi for Recognition of MD(Pathology) qualification u/s 11(2) of the IMC Act, 1956 immediately.
- 2. Date of practical examination has been informed as under:-

"01.05.2019 to 15.05.2019 (fixed by AKU, Patna) (06.05.2019 & 07.05.2019, fixed by HOD, Pathology, SKMC, Muzaffarpur)"

You are therefore once again, requested to forward your request u/s 11(2) through the affiliating university to the Central Govt., Ministry of Health & Family Welfare, New Delhi for Recognition of MD(Pathology) qualification alongwith clear cut practical examination dates.
